REPORT OF THE STUDENTS' GRIEVANCE REDRESSAL AND WELFARE COMMITTEE  
TO LOOK INTO THE COMPLAINT DATED 7<sup>TH</sup> FEBRUARY, 2024 FROM MS. BHAVYA  
GOEL, THIRD YEAR B.Arch. STUDENT AGAINST MS. PREET KHUNGER, THIRD  
YEAR B.Arch. STUDENT FORWARDED BY THE DIRECTOR OF THE COLLEGE VIDE  
HER NOTE DATED 8<sup>TH</sup> FEBRUARY, 2024.

The Committee called its meeting on 12<sup>th</sup> February, 2024. The Chairman apprised the members of the Committee that the Director of the College has forwarded a complaint dated 7<sup>th</sup> February, 2024 from Ms. Bhavya Goel, third year B.Arch. student against Ms. Preet Khunger, third year B.Arch. student. It was decided that both the students – Ms. Bhavya Goel and Ms. Preet Khunger may be called separately. Both the students appeared before the Committee. In the first instance, Ms. Bhavya Goel was called and the Committee requested her to explain in detail of the incident between her and Ms. Preet Khunger during the educational tour to Mumbai and Pune. Ms. Bhavya Goel informed that the incident took place on the evening of 2<sup>nd</sup> February, 2024. Ms. Preet Khunger began with verbal altercation and details of the version of the incident have been submitted by both the students in writing. Ms. Bhavya Goel mentioned names of some of her classmates namely Palak Jain, Ekansh Sood, Geetika Kadam, Yashna Rustogi and Rudraksh Gupta, those were present during the incident. The Committee called all the above students and asked them to submit their version in writing. One student Yashna Rustogi communicated, in writing, that she was not present at the time of the incident. Rest of the students submitted their version in writing. Ms. Preet Khunger was also called and the Committee heard her verbal version whereas she added that Mr. Rajneesh was also present during the incident and Mr. Rajneesh also submitted his version, in writing. The Committee asked Preet Khunger to submit her explanation in writing which she submitted vide her email dated 14<sup>th</sup> February, 2024. The Committee also called both the faculty members – Prof. Sheily Shrivastav and Prof. Mohd. Shoeb Alam, who accompanied the educational tour to Mumbai-Pune along with third year students. Both the faculty members were requested to submit their written statement. Accordingly, both the faculty members jointly submitted their statement vide their written statement dated 12<sup>th</sup> February, 2024. The Committee felt that the parents of both the students may also be called to know their views on the incident which took place between these two students.

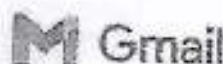

Subject: Urgent: Formal Complaint and Appeal for Immediate Action

Respected Authorities,

I am Bhavya, a third-year student of B.Arch. With a very heavy heart and a sense of urgency, I reach out to you as I am compelled to bring a matter of utmost concern to your attention regarding a distressing incident that unfolded during our recent educational trip to Mumbai and Pune from January 29th, 2024, to February 5th, 2024. The gravity of the situation demands an immediate and thorough response and undivided attention from college authorities and our institution.

Despite my prior attempts to address issues and resolve conflicts amicably with my classmate, Preet Khunger (a third-year student of B.Arch), the situation has regrettably escalated to an appalling level. The verbal disagreement during the trip not only escalated into a physical altercation initiated by Preet but also left me physically and emotionally vulnerable, resulting in subsequent health issues that required immediate medical attention.

The disturbing incident happened on the evening of February 2nd, 2024, around 10 pm. The incident started with me casually talking to my peers, and she began provoking me unnecessarily. Preet's unwarranted intrusion and provocation escalated the situation. To maintain composure and avoid confrontation I did not react; instead, I ignored her by saying thank you. This incident repeated, followed by several random comments aimed at irritating me, including persistent harassment and derogatory remarks pushed me to brink. It escalated further when she began shouting unnecessarily, then brought her finger very close to my eyes and physically attacked me. In self-defense, I pushed her back. Had I not done so, it could have led to a potentially serious injury, possibly requiring hospitalization. Faculty members intervened later, and I was sent back to my room. However, my condition deteriorated rapidly upon reaching the room, resulting in choking, crying, uncontrollable tears, physical tremors, anxiety attacks, shaking, and shivering. Several classmates, including Palak Jain, Ekansh Sood, Geetika Kadam, Yashna Rustagi, and Rudraksh Gupta, witnessed this. I have never experienced such a breakdown before, and it was deeply distressing.

My classmates insisted on calling an ambulance as my condition worsened, with my body temperature reaching 103 degrees. After composing myself, I felt it was necessary to inform my Studio Coordinators about the incident, my condition, and what transpired. During our discussion, Preet again displayed aggressive behavior. It was evident that she was the instigator. Our faculty member suggested counseling to resolve the conflict between us and recommended therapy for me, citing my emotional sensitivity. However, I believe this is not a viable solution given the severity of the situation. When conflicts escalate to physical altercations and vulgar language, they undoubtedly impact both mental and physical health. The situation has reached a point where resolution seems unattainable. My family, friends, and I demand decisive action to be taken.

The incident affected me to the extent that I developed a high fever for the remainder of the trip and could barely eat. My family and friends remained in constant contact with me and my faculty to ensure my well-being.

This incident is not an isolated occurrence. I am compelled to remind the authorities of prior instances wherein I endured the bullying and verbal abuse at the hands of Preet. I would like to bring to your attention previous instances of bullying and verbal

abuse on text by Preet Khunger in October. I have attached screenshots for your reference. Despite reporting this to our respected director, no substantial action was taken. A mere warning was issued, which did not deter further bullying. This recent incident underscores the urgent need for a comprehensive investigation and swift measures to ensure the safety and well-being of all students. I have attached the screenshots below as proof to her absurd and dirty language.

I implore the authorities to recognize that physical altercations and verbal harassment have severe implications for the collective mental health of the students. The impact of such incidents transcend physical harm, inflicting profound psychological jeopardising the sanctity of our learning environment. As a victim, I am left feeling vulnerable and marginalised, with profound sense of insecurity pervading my collegiate experience. I earnestly request a thorough inquiry into this matter and decisive actions to address Preet's recurrent aggressive behavior. The recent incident has deeply affected me and exacerbated existing issues. I now feel unsafe and suffocated in college. Despite seeking help from faculty members, my mental health has deteriorated due to the lack of action on previous reports and I have been dealing with all this since year 1 all on my own but now it has crossed limits. Had substantive action been taken earlier, the situation might have been different. The college must take a firm stance against such incidents to prevent their recurrence.

In the absence of a satisfactory resolution, I may be compelled to explore legal avenues to address the issue. I trust in your commitment to maintaining a safe and nurturing learning environment for all students. Your prompt attention to this matter is urgently required and highly appreciated.

Thank you for your understanding, empathy and unwavering commitment and cooperation to ensuring a safe and nurturing environment for all.
